1. **ALL ENTRIES TO BE LISTED ON REVERSE AND RETURNED AS SOON AS POSSIBLE FOR ADVERTISING PURPOSES.** Vendors **MUST** note on the entry form any reserves they may wish to place on items to be offered for sale. No reserve under £30 will be accepted.
2. Commission will be charged at the following rates in respect of each lot, **with a minimum charge of £5 PER LOT entered and an overall minimum charge of £10.00:- 10% on the first £2,500; 4% on the residue plus VAT.** All commission rates are inclusive of advertising and incidental expenses.
3. All items must be clearly marked and delivered to the sale site **BEFORE MIDDAY Monday 6th January.**
4. All items remain the property of the vendor until sold and paid for in full and at the vendors risk. Any unsold items must be removed from the sale site on the sale day and remain the vendors responsibility at all times.
5. Any item unsold due to failing to meet reserve must be collected within two hours of the end of the sale. Failure to do so the item will be re-entered into the next sale without reserve.
