2. Commission will be charged at the following rates in respect of each lot, **with a minimum charge of £5 PER LOT entered and an overall minimum charge of £10.00:- 10% on the first £2,500; 4% on the residue plus VAT.** All commission rates are inclusive of advertising and incidental expenses.
3. All items must be clearly marked and delivered to the sale site **BEFORE Friday 3rd January.**
4. All items remain the property of the vendor until sold and paid for in full and at the vendors risk. Any unsold items must be removed from the sale site on the sale day and remain the vendors responsibility at all times.
