3. **All items must be clearly marked and delivered to the sale site before midday Monday 28th October.**
4. All items remain the property of the vendor until sold and paid for in full and at the vendors risk. Any unsold items must be removed from the sale site on the sale day and remain the vendors responsibility at all times.
